Rider Skills Assessment

RedClick Rider Skills Assessment – Competence Levels

Level 4

A rider who has reached the stage where they can 'ride safely on their own in all normal conditions'. 'Normal conditions' include heavy urban traffic. They would be likely to pass the Department of transport test.

Level 3

A more experienced rider than Level 4 who is able to ride safely on fast dual carriageways (e.g. national primary routes), motorways (subject to licence restrictions) and 'country roads'. Riding in wet conditions and darkness would present no problems and hazard management skills will be consistent and predictable.

Level 2

A rider of a standard equating to a ROSPA Bronze/ IAM advanced standard. The assessed rider would display a high standard of hazard awareness, machine sympathy/control which is very close to that required for Level 1.

Level 1

A rider of a standard equating to ROSPA Silver standard. The assessed rider would display a high standard of hazard awareness, machine sympathy/control.

Note: The following rules apply to the type of bike used for the assessment.

- An assessment taken on an automatic is only valid for insurance on an automatic.
- An assessment taken on 50cc moped is only valid for insurance on up to a 125cc automatic.
- If the bike rider is looking to insure is 500cc or over, then the assessment must be taken on at least a 500cc bike.
